

## **Company Analysis - Group and Company Overview**


Cloudways was founded in 2012 and operates as a managed cloud hosting platform that provides simple onboarding and day-to-day management and purpose-built solutions to Small and Medium-Sized Businesses ("SMBs") who are looking to outsource their on-ramp to the internet. Cloudways help these SMBs offload the general complexities associated with cloud-based infrastructure.

Cloudways Limited ("Cloudways Malta"), having its registered office at 1st Floor Sqaq Lourdes St. Julians STJ3334, Malta, is the parent entity of the Cloudways Group, and is responsible for overall activities of the group as the software and domain IP owner. Cloudways Malta is the contracting and negotiating party with the customers.

The cloud hosting platforms that Cloudways provides allows customers to host websites and applications on a cloud vendor of their choice (i.e. Digital Ocean, Vultr, Linode, AWS, or Google Cloud) without having to worry about the DevOps complexities that come with self-managed infrastructure.

Effective from 5 April 2022, Cloudways Malta, became the Parent Company by virtue of 99% shareholding in Cloudways Platform (Private) Limited. ("Cloudways PK") through purchase of 2,970 ordinary shares.

Subsequent to the year ended 30 June 2022, DigitalOcean Holdings, Inc., having its registered office at 101 6th Avenue New York, United States, became the ultimate parent of Cloudways PK pursuant to acquisition of Cloudways Malta by DigitalOcean, LLC. Nevertheless, there have not been any material changes to Cloudways PK's business operations as a result of the acquisition through 31 December 2022.


- application program interfaces and shared private networking.
